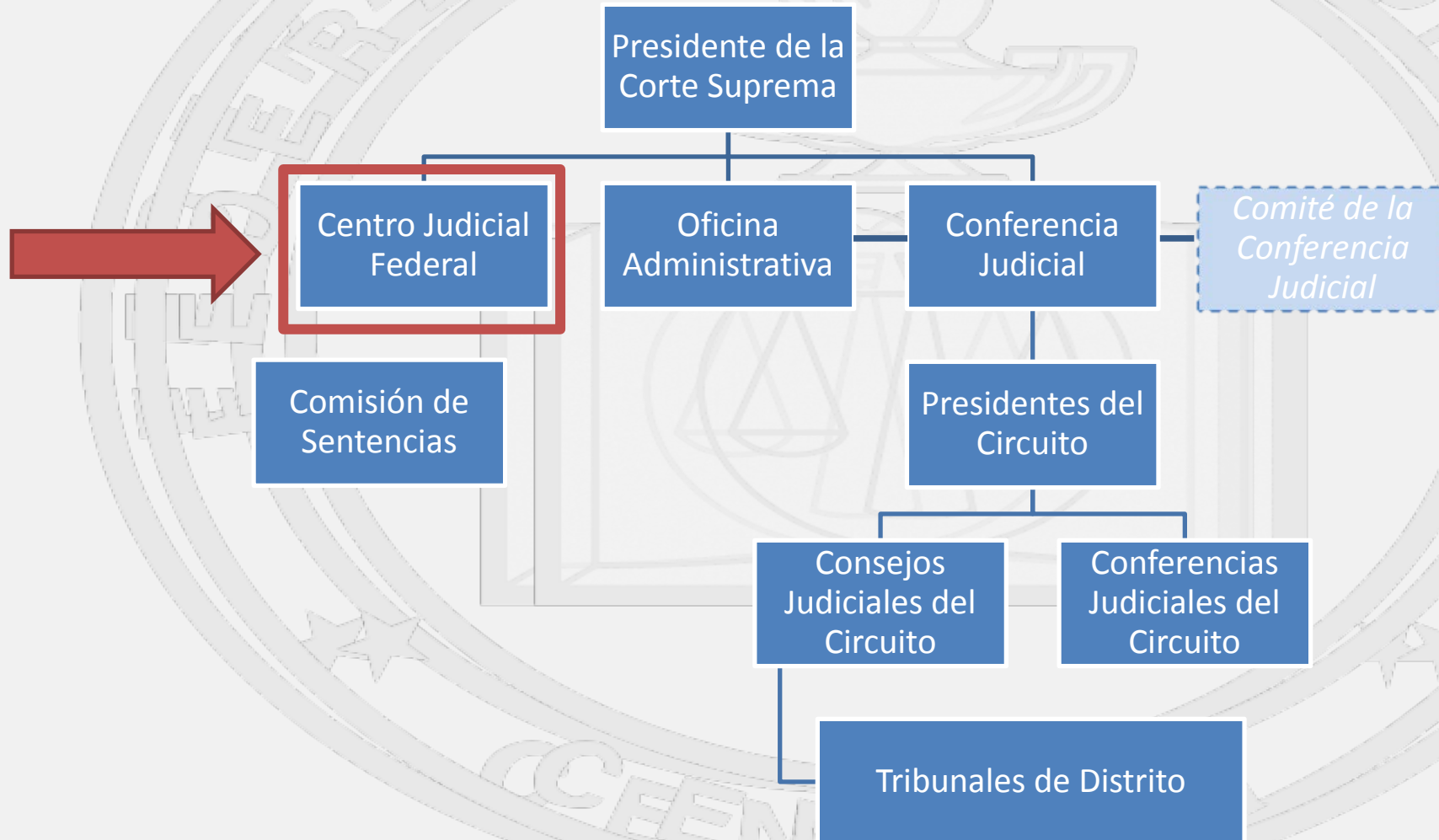

- Presupuesto: \$26.959.000 (2015)





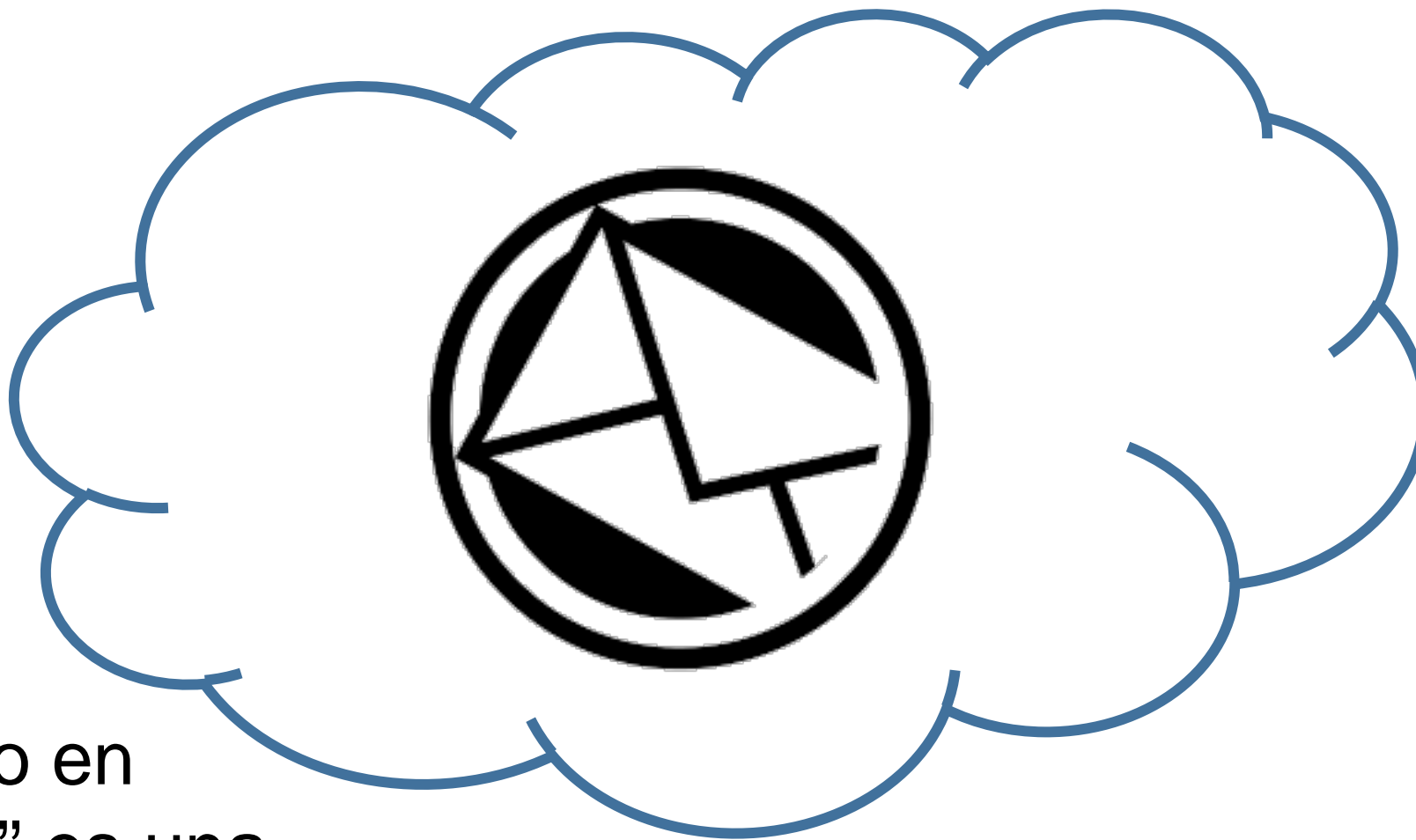
